## STATEMENT FOR REACH REGULATION

INGERSOLL RAND INDUSTRIAL IRELAND, as an equipment manufacturer of pumps, is duly informed of new obligations introduced by the Regulation (EC) No 1907/2006 of the European Parliament and of the Council as of 18 December 2006 concerning the Registration, Evaluation, Authorization and Restriction of Chemicals (REACH) as amended.

INGERSOLL RAND INDUSTRIAL IRELAND is conducting an in depth review of this regulation and all necessary steps to ensure full compliance of pump products sold throughout the EU at the dates set up by the above mentioned regulation.

Further, INGERSOLL RAND INDUSTRIAL IRELAND has initiated the necessary action with its suppliers to ensure that they will, in a timely manner, make the pre-registration and registration for the substances and preparations that INGERSOLL RAND INDUSTRIAL IRELAND uses.

INGERSOLL RAND INDUSTRIAL IRELAND is monitoring the list of substances and preparations that are purchased in order to determine if high risk or high concerned substances are present in the pump products being commercialized.

INGERSOLL RAND INDUSTRIAL IRELAND has noted that in Regulation 1907/2006 Article 2.1.b that the REACH application does not apply to substances on their own, in a preparation or in an article, which are subject to customs supervision, provided that they do not undergo any treatment or processing.

To-day, according to substance list or preparation already established, with respect to pump products:

- INGERSOLL RAND INDUSTRIAL IRELAND is not using High risk or High concerned substances contained in the list of substances candidates to Authorization published by the European Chemicals Agency (ECHA) updated 23 January 2024. This means that to-day no substance candidate to Authorization is used by INGERSOLL RAND INDUSTRIAL IRELAND either during the manufacturing process and/or in the equipment put into the market.
- 2. INGERSOLL RAND INDUSTRIAL IRELAND is using substance or preparation according to supplier technical data sheet. This means that INGERSOLL RAND INDUSTRIAL IRELAND does not have to develop specific exposure scenario according to its own use.
- 3. All substances used by INGERSOLL RAND INDUSTRIAL IRELAND are to-day already preregistered or registered according to the list available on the ECHA website.
- 4. INGERSOLL RAND INDUSTRIAL IRELAND is not using substances listed in Annex XIV List of Substances Subject to Authorization.

According to the REACH regulation, INGERSOLL RAND INDUSTRIAL IRELAND is an article producer.

Accordingly, INGERSOLL RAND INDUSTRIAL IRELAND has to transmit to its customers the information requested by the clause 33.1 of the regulation. According to list of "substances and preparations candidates for Authorization", last updated by ECHA updated 23 January 2024; INGERSOLL RAND INDUSTRIAL IRELAND can confirm that no "substances candidates to Authorization" with a concentration higher than 0,1 % of total article weight are present in the article put into the EU market.

INGERSOLL RAND INDUSTRIAL IRELAND engages to update this statement in accordance with all evolutions of regulations or product design changes.

According to the REACH Guidance document for article, INGERSOLL RAND INDUSTRIAL IRELAND pump products do emit substance intended for release in normal use or during maintenance.

INGERSOLL RAND INDUSTRIAL IRELAND requires its suppliers to comply with all applicable regulations, including, REACH.
