A meeting of the Governance Committee of the Salt River Project Agricultural Improvement and Power District (the District) convened at 9:30 a.m. on Wednesday, October 4, 2023, from the Hoopes Board Conference Room at the SRP Administration Building, 1500 North Mill Avenue, Tempe, Arizona. This meeting was conducted in-person and via teleconference in compliance with open meeting law guidelines. The District and Salt River Valley Water Users' Association (the Association) are collectively known as SRP.

Committee Members present at roll call were N.R. Brown, Chairman; M.J. Herrera, Vice Chairman; R.J. Miller and L.C. Williams.

Committee Members absent at roll call were R.C. Arnett, J.M. White Jr., and K.B. Woods.

Also present were President D. Rousseau; District Vice President C.J. Dobson; Board Members K.J. Johnson, A.G. McAfee, and S.H. Williams; Board Member L.D. Rovey of the Association; Council Vice Chairman J.R. Shelton; Council Liaisons M.B. Brooks and N.J. Vanderwey; Council Members M.L. Farmer, T.S. Naylor, and P.A. Van Hofwegen; Mmes. I.R. Avalos, M.J. Burger, A.P. Chabrier, M.K. Greene, L.F. Hobaica, G.A. Mingura, and C.M. Sifuentes; Messrs. J.M. Baran, J.D. Coggins, J.M. Felty, R.T. Judd, A.J. McSheffrey, R. Navarro, and M.J. In compliance with A.R.S. §38-431.02, Andrew C. Davis of the Corporate Secretary's Office had posted a notice and agenda of the meeting of the Governance Committee at the SRP Administration Building, 1500 North Mill Avenue, Tempe, Arizona, at 9:00 a.m. on Monday, October 2, 2023.

Chairman N.R. Brown called the meeting to order.

Consent Agenda

Chairman N.R. Brown requested a motion for Committee approval of the Consent Agenda, in its entirety.

On a motion duly made by Vice Chairman M.J. Herrera, seconded by Board Member L.C. Williams, the Committee unanimously approved and adopted the following item on the Consent Agenda:

Corporate Secretary J.M. Felty polled the Committee on Vice Chairman M.J. Herrera's motion to approve the Consent Agenda, in its entirety. The vote was recorded as follows:

Eligibility Requirements to Vote in SRP Elections

Using a PowerPoint presentation, Jim M. Pratt, SRP General Manager and Chief Executive Officer, stated that the purpose of the presentation was to provide information regarding the eligibility requirements to vote in SRP elections.

Mr. J.M. Pratt explained how Management oversees SRP's elections as follows: 1) SRP's self-governance is critical to the success of SRP, its customers and shareholders; 2) fundamental to SRP's existence and success is the provision and support of water to the lands with the reservoir boundary; 3) service provided to electric customers outside the reservoir boundary is identical including pricing, programs, reliability and customer service to those provided within the reservoir boundary; 4) the current voting system has been held to be legal and constitutional; 5) any changes in SRP voting or voter eligibility would require changes to Arizona statutes and the Association Articles of Incorporation; and 6) any recommendation for change will need approval of all four governing bodies. He introduced Michael J. O'Connor, SRP Associate General Manager and Chief Legal Executive.

Next, Mr. M.J. O'Connor provided the following overview of acreage based voting: 1) both the Association and the District have acreage voting systems with similar voting boundaries; 2) the Association's acreage voting system has been in place since 1903 and is set forth in the Association Articles of Incorporation; 3) the District's acreage voting system was put in place since 1937 and is set forth in the Arizona Revised Statutes, Title 48; and 4) both the Association and the District voting systems were drafted and designed in light of the relationship of the amount of land pledged for collateral (burdened land) and water rights that are appurtenant to the burdened land. He provided a map of the Association and District votable lands.

Mr. M.J. O'Connor provided an explanation of who is eligible to vote and who is not eligible to vote in the District elections. He provided a map of the District electric service area outlining the SRP power service area, Salt River Reservoir District, the Eastern Mining District, and the Indian Reservation.

Mr. M.J. O'Connor said that currently SRP customers outside of the District boundary are not eligible to vote in the District elections, and noted that SRP electric customers

outside the District boundary are treated the same as customers inside the boundary. He introduced Rob R. Taylor, SRP Associate General Manager and Chief Public Affairs and Corporate Services Executive.

Mr. R.R. Taylor informed the Committee of legislative issues that ought to be considered by the Board: volatile political environment; title 48 legislative risks; and One SRP unanimity is key to success.

Next, Mr. R.R. Taylor briefed the Committee that in 2019, SRP formed the Customer Utility Panel (CUP), with the aim of providing a formal voice for SRP residential customers who reside outside the District boundary. He provided a list of the CUP members and noted that the CUP members meet quarterly and communicate quarterly with the District Board.

Mr. R.R. Taylor reviewed governance survey data from the Large Public Power Council (LPPC), the American Public Power Association (APPA), and the CUP. He concluded with a discussion of voting inside the reservoir boundary, voting outside the reservoir boundary, and next steps.

Messrs. M.J. O'Connor and R.R. Taylor responded to questions from the Committee.

Copies of the PowerPoint slide used in this presentation are on file in the Corporate Secretary's Office and, by reference, made a part of these minutes.

Board Members M.V. Pace and P.E. Rovey entered the meeting during the presentation.

On a motion duly made by Vice Chairman M.J. Herrera, seconded by Board Member L.C. Williams and carried, the Committee convened into executive session at 10:09 a.m.

I particularly like the last two learning objectives: choose effective questions to ask as a director, to provide well-grounded input on strategy and distinguish between board practices that facilitate and hinder the alignment of an organization's short-term and long-term strategies.

Provision Regarding Public Comment

- Current Board Rules of Procedure

- Rule 8 – Public Comment:

“The District appreciates attendance by members of the public at its public meetings. While members of the public are welcome to attend, public comments are typically not accepted at these meetings. Members of the public who have comments or suggestions are asked to submit them in writing to the Corporate Secretary who, in turn, will forward them to the appropriate persons for review. Comments may be sent (i) by mail to the attention of the SRP Corporate Secretary, mail station PAB215, P.O. Box 52025, Phoenix, Arizona 85072-2025, or (ii) by email to John.Felty@srpnet.com.”

Provision Regarding Agenda

- Current Board Rules of Procedure

- Rule 8: Board Agenda Items, Section A:

“The President shall set the agenda for the meetings of the Board, but in addition to the President, any two members of the Board may place an item on the agenda for the next meeting of the Board by submitting their request in writing to the Corporate Secretary; provided, however, if the request is made too late for the Corporate Secretary to comply with the requirements of the Open Meeting Law, then the item shall be placed on the agenda for the next subsequent meeting of the Board, provided further, that if there exists a Board Committee to which such item normally would be presented first, the item shall be placed on the agenda of that committee for discussion and, if appropriate, a recommendation, before being placed on a subsequent Board agenda.”

Provision Regarding Agenda Continued

- Current Board Rules of Procedure

- Rule 8: Board Committee Agenda Items, Section B:

“Similarly, the President shall set the agenda for all Board Committee meetings, but in addition to the President, any two members of a Committee may place an item on the agenda for the next meeting of the Committee by submitting their request in writing to the Corporate Secretary; provided, however, that (i) the consent of the President shall be required if the agenda item is not within the business function of that committee and (ii) if the request is made too late for the Corporate Secretary to comply with the Open Meeting Law, then the item shall be placed on the agenda for the next subsequent meeting of that committee.”

Provision Regarding Committee Structure

- Current Board Rules of Procedure

- Rule 4: Standing and Special Committees:
 - a) The president or the Board may establish standing and special committees. A special committee is one given an assigned matter upon which to make a recommendation or report to the Board and once the task is completed, the committee ceases to exist. A standing committee is one given a continuing function such as having all business of a certain type referred to it for a recommendation to the Board.
 - b) The Board shall determine membership of committees created by the Board, including designation of the Chair and Vice Chair. The Board must also approve the membership of committees created and appointed by the President, including the designation of the Chair and Vice Chair.

Provision Regarding Committee Structure Continued

- Current Board Rules of Procedure
 - Rule 4: Standing and Special Committees:
 - c) Subsection (b) of this rule notwithstanding, if there fails to be a quorum in attendance at a Board Committee meeting, the President or the Chair of the Committee, without further Board approval, may appoint ad-hoc members sufficient to cause there to be a quorum for purposes of that meeting if there are sufficient Board members in attendance who are not already members of that committee.
 - d) If the President or Chair declines to call a meeting of a committee within a reasonable time, any two members of the committee may call a meeting.

Provision Regarding Role of Committee Chairs

- Current Board Rules of Procedure

- Rule 6: Chair of Board and Committee Meetings:

“The President, or in the absence of the President, the Vice President, shall preside as Chair at all meetings of the Board. *[A.R.S. 48-2364 and Bylaws Article VIII, Sections 2 and #]* At any meeting of the Board or Board Committee, the Chair may participate in debate, make motions and vote on all matters. If neither the Chair nor Vice Chair is available to attend a given meeting of a Board Committee, the President may appoint a temporary chair from the remaining members of the committee.”

RULES OF PROCEDURE OF THE SALT RIVER PROJECT AGRICULTURAL IMPROVEMENT AND POWER DISTRICT BOARD OF DIRECTORS

(Adopted February 7, 2011; Amended May 7, 2012; Amended July 13, 2015; Amended May 1, 2017)

Rule 1: General Rules

The Salt River Project Agricultural Improvement and Power District Board of Directors ("Board") shall determine its own rules of procedure for the conduct of public meetings, subject, at all times, to applicable laws and bylaws. (Amended May 7, 2012)

Rule 2: Conflict of Interest

The provisions of Arizona Revised Statutes (A.R.S.) Title 38, Article 8, Conflict of Interest of Officers and Employees, §§ 38-501 to 38-511, inclusive, are incorporated herein by reference. Consistent therewith, each member of the Board shall file, on an annual basis, on a form provided by the Corporate Secretary's Office, a disclosure of any potential conflict of interest that may arise. (Amended May 7, 2012)

Rule 3: Board Meetings

- a) The Board shall hold regular meetings in its office on the first Monday in March, June, September and December, and such special meetings as required for the appropriate transaction of business. If the day prescribed for a meeting is a legal holiday, the board shall meet on the Monday following the legal holiday. [A.R.S. § 48-2333(A)] (Amended May 7, 2012)
- b) Special meetings may be ordered on the call of the President or a majority of the members of the Board. Three days' notice to any member not joining in the order shall be given by the Corporate Secretary, and only the business specified in the order shall be transacted at the special meeting. [A.R.S. § 48-2333(B)]
- c) All meetings shall be public with the exception of executive and closed sessions held for such purposes as are allowed by law. All public meetings and executive sessions shall conform to the requirements of the Arizona Open Meeting Law. [A.R.S. § 38-431, et seq] Closed sessions shall conform to the requirements of A.R.S. §30-805(B).
- d) A majority of the members of the Board shall constitute a quorum for the transaction of business. [A.R.S. §48-2333(C)] (Adopted May 7, 2012)
- e) Minutes of all proceedings of the Board shall be kept by the Secretary and all records of the Board, other than those which are privileged or confidential, shall be open to public inspection during business hours. [A.R.S. §48-2333(D)] (Adopted May 7, 2012)

Rule 4: Standing Committees (Amended May 7, 2012)

- a) The President or the Board may establish Standing Committees. A Standing Committee is one given a continuing function such as having all business of a certain type referred to it for a recommendation to the Board. (Amended May 7, 2012)
- b) The President, subject to Board approval, shall designate the members of the Standing Committee, including the designation of the Chair and Vice Chair. No appointments, removals, or changes to the membership of a Standing Committee, including the designation of the Chair and Vice Chair, shall become effective until approved by the Board. (Amended May 7, 2012)
- c) Subsection (b) of this Rule notwithstanding, if there fails to be a quorum in attendance at a Board Committee meeting, the President or the Chair of the Committee, without further Board approval, may appoint temporary replacement members sufficient to cause there to be a quorum for purposes of that meeting if there are sufficient Board members in attendance who are not already members of that committee. (Amended May 7, 2012)
- d) Standing Committees shall hold regular meetings as required for the transaction of business. Either the President or the Chair of a Committee may call a meeting of the Committee and shall do so by and through the Corporate Secretary's Office in coordination with the President's Office and the General Manager. (Adopted May 7, 2012)
- e) As of April 3, 2012, the Board had the following Standing Committees: (1) Audit, (2) Community Relations, (3) Compensation, (4) Facilities and Support Services, (5) Finance and Budget, (6) Governance, (7) Power, and (8) Water. (Adopted May 7, 2012)

Rule 5: Special Committees (Adopted May 7, 2012)

- a) The President or the Board may establish Special Committees. A Special Committee is one given an assigned matter upon which to make a recommendation or report to the Board and once the task is completed, the Committee ceases to exist. (Adopted May 7, 2012)
- b) If the President establishes a Special Committee, the President, subject to Board approval, shall designate the members of the Special Committee, including the designation of the Chair and Vice Chair. No appointments, removals, or changes to the membership of a Special Committee, including the designation of the Chair and Vice Chair, shall become effective until approved by the Board. (Adopted May 7, 2012)
- c) If the Board establishes a Special Committee, the Board shall designate the members of the Special Committee, including the designation of the Chair and Vice Chair. No appointments, removals, or changes to the membership of a

Special Committee, including the designation of the Chair and Vice Chair, shall become effective until approved by the Board. (Adopted May 7, 2012)

- d) Subsection (b) of this Rule notwithstanding, if there fails to be a quorum in attendance at a Board Committee meeting, the President or the Chair of the Committee, without further Board approval, may appoint temporary replacement members sufficient to cause there to be a quorum for purposes of that meeting if there are sufficient Board members in attendance who are not already members of that committee. (Adopted May 7, 2012)
- e) The Special Committee shall hold meetings as required to complete its task and to issue its recommendation or report to the Board as directed. Either the President or the Chair of the Special Committee may call a meeting of the Committee and shall do so by and through the Corporate Secretary's Office in coordination with the President's Office and the General Manager. (Adopted May 7, 2012)
- f) As of April 3, 2012, there were no Special Committees. (Adopted May 7, 2012)

Rule 6: Board Agenda Items

- a) The President shall set the agenda for meetings of the Board, but in addition to the President, any two members of the Board may place an item on the agenda for the next meeting of the Board by so indicating during the discussion of future agenda topics during a duly called meeting of the Board or by submitting their request in writing, including, without limitation, e-mail or facsimile, to the Corporate Secretary; provided, however, if the request is made too late for the Corporate Secretary to comply with the requirements of the Open Meeting Law, then the item shall be placed on the agenda for the next subsequent meeting of the Board; provided further, that if there exists a Board Committee to which such item normally would be presented first, the item shall be placed on the agenda of that committee for discussion and, if appropriate, a recommendation, before being placed on a subsequent Board agenda. (Amended May 7, 2012)
- b) As a general practice, the President and the General Manager/CEO shall coordinate when an item is placed on the agenda, and the General Manager/CEO shall initiate and finalize the Board Agenda Memorandum for such items. (Adopted May 7, 2012)
- c) The Corporate Secretary, under the direction of the President and the General Manager/CEO, shall disseminate copies of agendas and background material, including any materials submitted by a Board member in relation to an agenda item, to the President, Vice President, members of the Board, and General Manager. (Amended May 7, 2012)
- d) Except as otherwise allowed by the Arizona Open Meeting Law, agendas and meeting notices shall be made public at least 24 hours in advance of the meeting (excluding Sundays and legal holidays) both by posting outside the main lobby of

the Board's office and posting on the District's web site [www.srpnet.com].
(Amended May 7, 2012)

- e) The President may include items on a Consent Agenda, which items may be adopted, rejected, or continued, as a group, without discussion. At the request of any Board member, an individual item shall be removed from the Consent Agenda and considered separately immediately following the Consent Agenda. (A Consent Agenda is a group of items that is moved and voted on, without discussion, as a package. It may be used for routine matters not needing additional explanation or discussion.)
- f) At each Board meeting, there shall be an agenda item to approve the minutes from the previous Board meeting. (Adopted May 7, 2012)

Rule 7: Committee Agenda Items (Adopted May 7, 2012)

- a) The President shall set the agenda for all Board Committee meetings, but in addition to the President, (i) the Chair of a Committee may set agenda items for that Committee, and (ii) any two members of the Board may place an item on the agenda for the next meeting of an appropriate Committee by so indicating during the discussion of future agenda topics during a duly called meeting of the Board or a Committee or by submitting their request in writing, including, without limitation, e-mail or facsimile, to the Corporate Secretary; provided, however, that (i) the consent of the President shall be required if the agenda item is not within the business function of that committee or (ii) if the request is made too late for the Corporate Secretary to comply with the Open Meeting Law, then the item shall be placed on the agenda for the next subsequent meeting of that Committee. (Adopted May 7, 2012)
- b) As a general practice, the President, the Committee Chair and the General Manager/CEO shall coordinate when an item is placed on the agenda, and the General Manager/CEO shall initiate and finalize the Board Agenda Memorandum for such items. (Adopted May 7, 2012)
- c) The Corporate Secretary, under the direction of the President and the General Manager/CEO, shall disseminate copies of agendas and background material, including any materials submitted by a Board member in relation to an agenda item, to the President, Vice President, members of the Board, and General Manager. (Adopted May 7, 2012)
- d) Except as otherwise allowed by the Arizona Open Meeting Law, agendas and meeting notices shall be made public at least 24 hours in advance of the meeting (excluding Sundays and legal holidays) both by posting outside the main lobby of the Board's office and posting on the District's web site [www.srpnet.com]. (Adopted May 7, 2012)
- e) The President may include items on a Consent Agenda, which items may be adopted, rejected, or continued, as a group, without discussion. At the request of

any Board member, an individual item shall be removed from the Consent Agenda and considered separately immediately following the Consent Agenda. (A Consent Agenda is a group of items that is moved and voted on, without discussion, as a package. It may be used for routine matters not needing additional explanation or discussion.) (Adopted May 7, 2012)

- f) At each Committee Meeting, there shall be an agenda item to approve the minutes from the previous Committee meeting. (Adopted May 7, 2012)

Rule 8: Chair of Board and Committee Meetings (Renumbered May 7, 2012)

The President, or in the absence of the President, the Vice President, shall preside as Chair at all meetings of the Board. *[A.R.S. 48-2364 and Bylaws Article VIII, Sections 2 and 3]* At any meeting of the Board or a Board Committee, the Chair may participate in debate, make motions and vote on all matters. If neither the Chair nor Vice Chair is available to attend a given meeting of a Board Committee, the President may appoint a temporary chair from the remaining members of the committee.

Rule 9: Decorum and Order (Renumbered May 7, 2012)

The Chair shall preserve decorum and decide all questions of order, subject to appeal to the Board.

- a) During Board and Board Committee meetings, the members of the Board shall preserve order and decorum and shall not delay or interrupt the proceedings or refuse to obey the orders of the Chair or the Rules of the Board. Every Board member desiring to speak shall address the Chair and, upon recognition by the Chair, shall confine all comments to the question under debate and shall avoid any disrespectful or otherwise inappropriate remarks. Once recognized, a Board member shall not be interrupted while speaking unless called to order by the Chair or unless a point of order is raised by another Board member. If a Board member is called to order while speaking, the Board member shall immediately cease speaking until the question of order is determined. If ruled to be in order, the Board member shall be permitted to proceed. If ruled to be not in order, the Board member shall remain silent or shall alter all remarks so as to comply with the rules of the Board. The members of the Board shall confine their questions to the particular issues before the Board. If the Chair fails to act, the Board may vote to direct the Chair to enforce the rules, in which case the Chair shall so act. (Amended May 7, 2012)
- b) The Chair shall have the authority to preserve decorum in meetings as far as the audience, staff members and District employees are concerned. Any remarks shall be addressed to the Chair and to any or all members of the Board. Without permission from the Chair, no staff member, other than the staff member who has the floor, shall enter into any discussion, either directly or indirectly.
- c) Attendees of Board and Committee meetings shall also observe the same rules of propriety, decorum and good conduct applicable to members of the Board. See

also Rule 10 concerning comments by members of the public. Any person making personal, impertinent, and slanderous remarks, or who becomes boisterous while addressing the Board or while attending the Board meeting, may be removed from the room if so directed by the Chair. Unauthorized remarks from the audience, stomping of feet, whistles, yells, or similar demonstrations shall not be permitted by the Chair, who shall direct that such offenders be removed from the room. Should the Chair fail to act, any member of the Board may vote to direct the Chair to enforce the rules, in which case the Chair shall so act. (Amended May 7, 2012)

Rule 10: Public Comments (Renumbered May 7, 2012)

The District appreciates attendance by members of the public at its public meetings. While members of the public are welcome to attend, public comments are typically not accepted at these meetings. Members of the public who have comments or suggestions are asked to submit them in writing to the Corporate Secretary who, in turn, will forward them to the appropriate persons for review. Comments may be sent (i) by mail to the attention of the SRP Corporate Secretary, mail Station PAB215, P.O. Box 52025, Phoenix, Arizona 85072-2025, or (ii) by email to John.Felty@srpnet.com.

Rule 11: Telephonic or Electronic Attendance at Meetings (Renumbered and Amended May 1, 2017)

The Board prefers and encourages all members to attend and participate in person (i.e. actual physical attendance) at all meetings to which they are a member of. The Board nonetheless recognizes that there may be occasions when in-person participation is not reasonably feasible. In such situations, and upon a determination of good cause by the chair of the meeting, the affected member(s) may participate in a meeting of the Board or a Board Committee, and vote, by conference call or other approved electronic means subject to the following conditions: (Amended May 1, 2017)

- a) The member may vote on all matters so long as he or she was present, telephonically or electronically, for the roll call and was able to participate in the discussions and presentations related to the item and not just for the vote; (Amended May 1, 2017)
- b) Reasonable means must be used to ensure that members of the Board or Committee and members of the public are able to hear the participation of telephonic and electronic attendees in compliance with the Arizona Open Meeting Law; and (Amended May 1, 2017)
- c) A member who intends to participate telephonically or electronically in any Board or Board Committee meeting must provide the Corporate Secretary with advance notice of his or her intent. Such advance notice must be provided as soon as reasonably practicable. (Amended May 1, 2017)

In the event of an SRP or civil emergency, such may require a special meeting on short notice. In such event, the Corporate Secretary shall contact all members of the committee, and members shall be able to participate and vote, by conference call or other

approved electronic means subject to the following conditions: (Renumbered and Amended May 1, 2017)

- a) The member may vote on all matters so long as he or she was present, telephonically or electronically, for the roll call and was able to participate in the discussions and presentations related to the item and not just for the vote; and (Adopted May 1, 2017)
- b) Reasonable means must be used to ensure that members of the Board or Committee and members of the public are able to hear the participation of telephonic and electronic attendees in compliance with the Arizona Open Meeting Law. (Adopted May 1, 2017)

Rule 12: Limitation of Debate (Renumbered May 7, 2012)

Without the permission of the Chair, no member of the Board shall be allowed to speak more than once upon any one subject until all members of the Board have had an opportunity to speak, nor for a longer time than five (5) minutes. However, debate and discussion shall be allowed even without a pending motion.

Rule 13: Need for a Second for Motions (Renumbered May 7, 2012)

Motions do not require a second before being debated; however, all motions require a second in order to be voted on.

Rule 14: Voting (Renumbered May 7, 2012)

- a) Questions for consideration by the Board or a Board Committee may be voted upon by voice, show of hands or secret ballot, to the extent allowed by law, unless a roll call is otherwise required by law or requested by any member of the Board. During a roll call vote it shall be out of order for members to explain their vote. All roll call votes shall be taken alphabetically, provided that the Chair shall be called last.
- b) Unless provided otherwise by applicable law, the By-laws or these Rules, all actions, whether by the Board or a Board Committee, shall be determined by majority vote of those members present and voting at a meeting in which a quorum is present. (Amended May 7, 2012)

Rule 15: Motions to Postpone (Table) (Renumbered May 7, 2012)

A motion to postpone to a certain time (such as the next meeting) shall preclude all amendments or debate on the subject under consideration, is debatable and can be amended (such as an amendment to change the time to which the matter would be deferred). A motion to postpone indefinitely, on the other hand, cannot be amended.

Rule 16: Motions to Amend a Motion (Renumbered May 7, 2012)

A motion to amend a proposed amendment shall be in order, but a motion to amend an amendment to an amendment shall not be introduced. At any point in time, only one proposed amendment to the original motion can be under consideration and only one proposed amendment to the amendment can be under consideration. Any other proposed amendments would be out of order. Once an amendment has been considered, another motion to amend can be moved. An amendment modifying the intention of a motion shall be in order, but an amendment relating to a different matter shall not be in order. See Rule 18 for motions to suspend or amend these Rules. (Amended May 7, 2012)

[Example: A motion is made and seconded to approve the execution of a contract ("Main Motion"). A motion is then made and seconded to amend the Main Motion to require that the contract be signed by a particular date ("Original Amendment to the Main Motion"). No other motion to amend the Main Motion would be in order until the Original Amendment to the Main Motion had been considered. However, there could be a motion and second to amend the Original Amendment to the Main Motion, for example, to add an additional requirement that the contract be signed by the President and attested to by the Corporate Secretary ("Amendment to the Original Amendment"). No other proposed amendments to the Original Amendment to the Main Motion would be in order until that proposed amendment had been considered. In this scenario, there would first be a vote on the proposed Amendment to the Original Amendment to determine whether the Original Amendment would be deemed amended (to add the requirement of the President's and Secretary's signatures). Then, assuming no other amendments were proposed, the Original Amendment to the Main Motion would be voted on (as it may or may not have been amended). Then the Original Motion (as it may or may not have been amended) would be voted on].

Rule 17: Motion to End Debate and Call for a Vote on the Question (Renumbered May 7, 2012)

After being recognized by the Chair, any member may make a motion to end debate on a motion under consideration and call for the vote ("Motion to End Debate and Call the Question"). However, if the debate has not otherwise ended and there are members who have not yet been heard, the Motion to End Debate and Call the Question must receive a second and then receive at least a two-thirds vote of those present and voting. Similarly, when nominations are being taken for an office or other appointment, a call for the vote before all members have had the opportunity to make a nomination (thus ending the opportunity for further nominations) must be seconded and receive at least a two-thirds vote of those present and voting.

Rule 18: Suspend or Amend the Rules (Renumbered May 7, 2012)

- a) With prior notice of a proposed suspension, the Board or a Committee of the Board may suspend these Rules by a 2/3 vote of those in attendance and voting or, without prior notice, by unanimous vote of those in attendance and voting.

- b) With prior notice of a proposed amendment, the Board may amend these Rules by a 2/3 vote of those in attendance and voting or, without prior notice, by unanimous vote of those in attendance and voting.

Rule 19: What Other Rules Shall Govern (Renumbered May 7, 2012)

The rules of parliamentary practice comprised in Robert's Rules of Order Newly Revised ("Robert's Rules"), latest edition, shall govern the Board in all cases to which such rules are applicable, provided that they do not conflict with applicable law, the By-Laws or these Rules. For purposes of Robert's Rules, the Board shall be deemed a "small board" as defined therein. (Amended May 7, 2012)

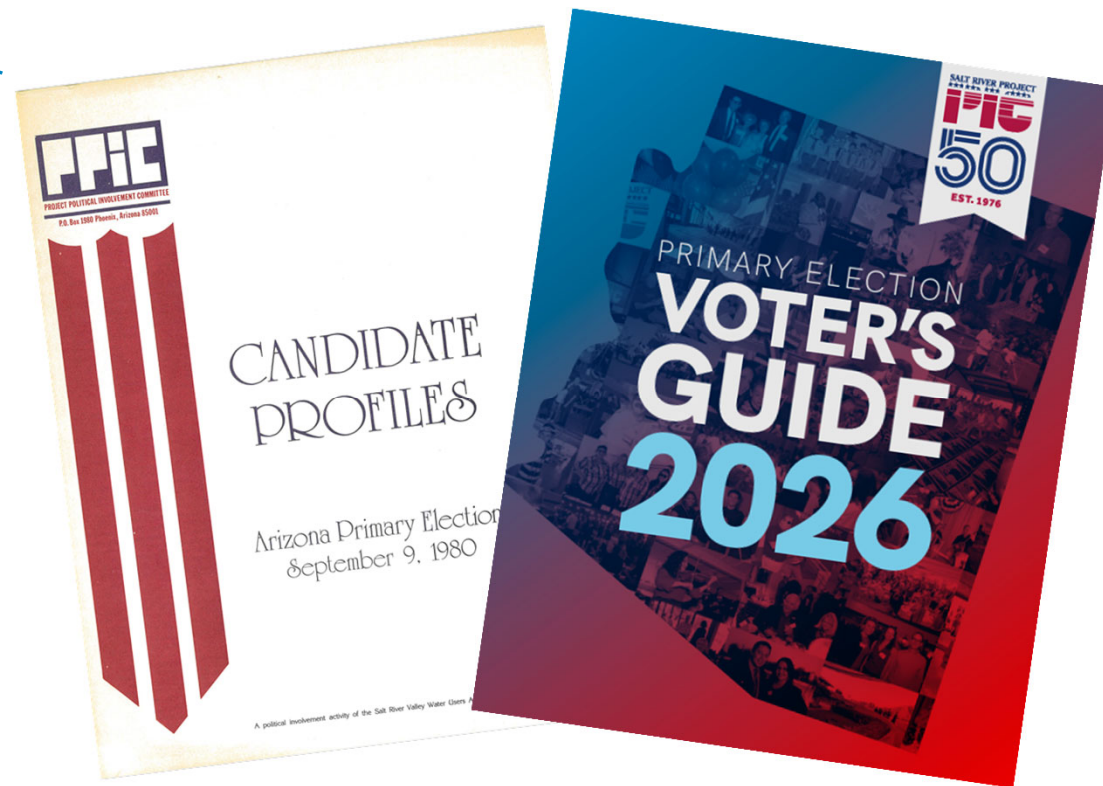
PIC Events – 2026 PIC Picnic

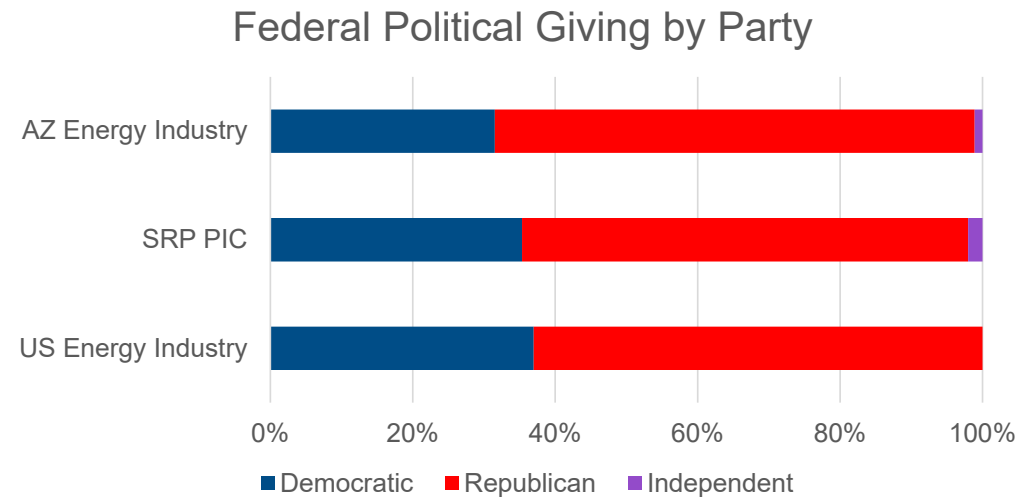

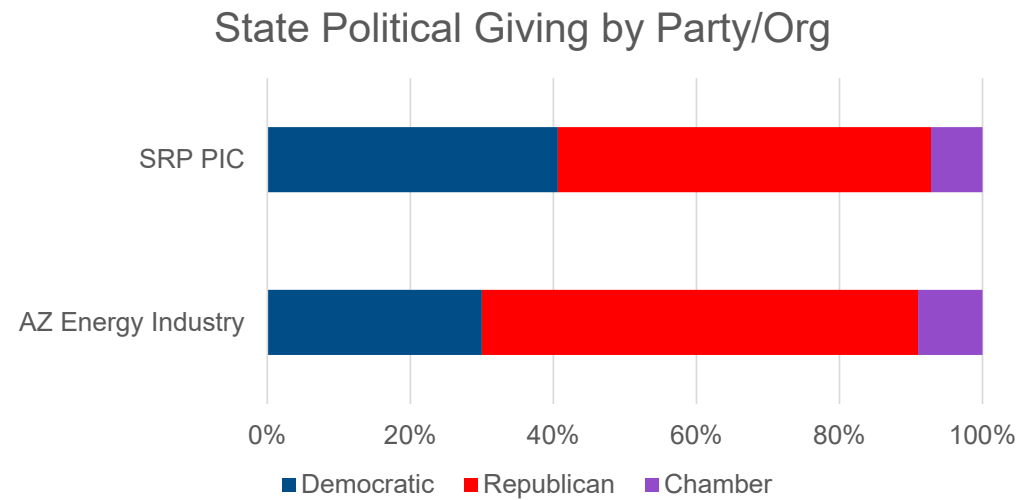

WHAT TO BRING TO YOUR POLLING PLACE

Every qualified voter is required to show proof of identity at the polling place before receiving a ballot. Acceptable forms of identification with photograph, name and address of the voter (one required):

- Valid Arizona driver's license
- Valid Arizona non-operating identification license
- Tribal enrollment card or other form of tribal identification
- Valid U.S. federal, state or local government-issued identification

Acceptable forms of identification without a photograph (two required):

- Utility bill that is dated within 90 days of the date of the election
- Bank or credit union statement that is dated within 90 days of the election
- Valid Arizona vehicle registration
- Indian census card
- Property tax statement of the elector's residence
- Vehicle insurance card
- Valid U.S. federal, state or local government-issued identification, including a voter registration card issued by the county recorder
- Tribal enrollment card or other form of tribal identification
- Recorder's certificate
- Any mailing to the elector marked "Official Election Material"

Governing Policy

Policy HR-BEN-030

- Adopted by SRP Board in 2015
- Modified in 2021



Enterprise Human Resources Policy

Mandatory Retirement

1.0 Purpose

To allow for a planned and orderly transition of high policymaking, executive leadership positions at Salt River Project.

2.0 Scope / Applicability

This policy applies to employees in the following positions with two or more years of tenure in the position, who are at least age 65, and who are entitled to collect an immediate, nonforfeitable retirement benefit of at least \$44,000 annually:

- a) General Manager and Chief Executive Officer
- b) Associate General Manager

3.0 Policy Statements

3.1. Eligible Employees must retire upon attaining age 66.

3.2. The employment of an Eligible Employee can be extended for a maximum of two (2) one-year terms if it is determined that such extension serves the best interest of Salt River Project. While an extension cannot exceed one-year, it is permissible to extend employment of an Eligible Employee for less than one-year.

Enterprise Human Resources Procedure

Mandatory Retirement Procedure

1.0 Purpose

This procedure identifies the actions required to develop and execute an extension of employment beyond age 66 for Eligible Employees.

2.0 Scope / Applicability

This procedure applies to employees in the following positions with two or more years of tenure in the position, who are at least age 65, and who are entitled to collect an immediate, nonforfeitable retirement benefit of at least \$44,000 annually:

- a) General Manager and Chief Executive Officer
- b) Associate General Manager

3.0 Procedure

3.1. Twelve (12) months before an employee's mandatory retirement date, the Associate General Manager and Chief Human Resources Executive notifies the authorizing authority if an executive meets the qualifications of an Eligible Employee.

3.1.1. The Compensation Committee and SRP Board are notified if the General Manager and Chief Executive Officer is an Eligible Employee.

3.1.2. The General Manager and Chief Executive Officer is notified if an Assistant General Manager is an Eligible Employee.
