While I appreciate SRP's commitment to gradualism in the face of rising costs, the proposed E16 plan represents an increase of 25 to 40 percent, depending on season, for my current usage under E27P, even if I were able to move 40 percent of my usage to the new super off-peak times. The proposed E28 TOU plan is little better - customers will pay a premium for energy, relative to the basic plan, of 16-25 percent or more for 17 hours per day. In my opinion, there is little reason for residential customers to elect any but the basic plan, because the financial incentives to conserve during peak hours on the proposed E16 and E28 plans are too small to be worth the trouble. The proposed plans represent a very large cost increase to current demand-plan residential customers.
