**NOTICE OF HEARING**

21 **A PUBLIC HEARING WILL BE HELD** before the Arizona Power Plant and  
22 Transmission Line Siting Committee (Committee) regarding the application of Salt River  
23 Project Agricultural Improvement and Power District (SRP or Applicant) for a Certificate  
24 of Environmental Compatibility (CEC) authorizing the above-captioned case (the Project).  
25 The Project contemplates the construction of a new expanded substation located entirely on  
26 a single customer-owned 187 acre parcel (Property). While the ultimate configuration will  
27 await the determination of specific customer needs, and will be constructed over time, the  
Project will contain a switchyard and associated structures, and at total build out the site  
could contain multiple distinct transformer locations and up to twenty-two high voltage  
distribution structures supporting up to ten circuits. The switchyard will interconnect to the  
existing Browning-Santan 230kV transmission line, which is located immediately north of  
the Property.

All Project components are located in the City of Mesa, Arizona within Maricopa  
County. A general location map of the Project is attached as Exhibit A.

1 The hearing will commence at the Superstition Springs Golf Course, 6542 E.  
2 Baseline Road, Mesa, Arizona 85206 on November 5, 2019, at 10:00 a.m., and will continue  
3 weekdays through November 8, 2019, as necessary, beginning at 9:00 a.m. on each day. If  
4 a tour is taken, it will begin on November 6, 2019, at 9:00 a.m., or an alternative date and  
5 time set by the Chairman of the Committee (Chairman).

7 Applicant's and Arizona Corporation Commission's (ACC) websites.

12 **SESSION ON NOVEMBER 5, 2019, BEGINNING AT 6:00 P.M., AT THE**  
13 **SUPERSTITION SPRINGS GOLF COURSE, 6542 E. BASELINE ROAD, MESA,**  
14 **ARIZONA 85206. PUBLIC COMMENT MAY ALSO BE TAKEN AT THE**  
15 **BEGINNING OF EACH HEARING DAY, OR AT OTHER TIMES DURING THE**  
16 **HEARING AT THE DISCRETION OF THE CHAIRMAN.**

17 The Chairman may, at his discretion, recess the hearing to a time and place to be  
18 announced during the hearing, or to be determined after the recess. The date, time and place  
19 at which the hearing will be resumed will be posted on the above-noted Project website and  
20 the ACC website.

21 **NOTE: NOTICE OF ANY SUCH RESUMED HEARING WILL BE GIVEN;**  
22 **HOWEVER, PUBLISHED NOTICE OF SUCH A RESUMED HEARING IS NOT**  
23 **REQUIRED.**

24 The Committee may conduct a tour of the Project area. The map and itinerary of any  
25 such tour will be available at the hearing and posted on the Project website. Members of  
26 the public may follow the Committee on the tour. During the tour, the Committee may hear  
27 testimony at stops on the tour concerning where the stops are located, what is visible at the

1 stops, and the relevance of the location and view to the Application and Project. No other  
2 discussion or deliberation concerning the Application will occur during the tour. A court  
3 reporter or recording device will record any testimony taken on the tour for transcription.

4 Copies of the Application, containing detailed maps of the Project site and detailed  
5 information about the Project, and prehearing and hearing transcripts, will be available for  
6 inspection at the following locations:

12 Each county, municipal government, and state agency interested in the Project that  
13 desires to be a party to the proceedings shall, not less than ten days before November 5,  
14 2019, file a Notice of Intent to Become a Party with the Docket Control, Arizona  
15 Corporation Commission, 1200 West Washington Street, Phoenix, Arizona 85007.

16 Any domestic, non-profit corporation or association formed in whole or in part to  
17 promote conservation or natural beauty; to protect the environment, personal health or other  
18 biological values; to preserve historical sites; to promote consumer interests; to represent  
19 commercial and industrial groups; or to promote the orderly development of the area in  
20 which the Project is located that desires to become a party to the proceedings shall, not less  
21 than ten days before November 5, 2019, file a Notice of Intent to Become a Party with  
22 Docket Control, Arizona Corporation Commission, 1200 West Washington Street, Phoenix,  
23 Arizona 85007.

24 The Committee or the Chairman, at any time deemed appropriate, may make other  
25 persons parties to the proceedings. Any person may make a limited appearance at a hearing  
26 by filing a statement in writing with the Docket Control, Arizona Corporation Commission,  
27 1200 West Washington Street, Phoenix, Arizona 85007, not less than five days before

1 November 5, 2019. A person making a limited appearance shall not be a party or have the  
2 right to present testimony or cross-examine witnesses.

3 This proceeding is governed by Arizona Revised Statutes (A.R.S.) §§ 40-360 to 40-  
4 360.13 and Arizona Administrative Code Rules R14-3-201 to R14-3-220. No substantive  
5 communication not in the public record may be made to any member of the Committee.  
6 The written decision of the Committee will be submitted to the ACC pursuant to A.R.S.  
7 § 40-360.07. Any person intending to be a party to the proceedings on the matter before  
8 the ACC must be a party to the proceedings before the Committee.
