NOTICE OF HEARING

A PUBLIC HEARING WILL BE HELD before the Arizona Power Plant and Transmission Line Siting Committee (“Committee”) regarding the Application of SALT RIVER PROJECT AGRICULTURAL IMPROVEMENT AND POWER DISTRICT (“Applicant”) for a Certificate of Environmental Compatibility (“CEC”) authorizing construction of the Marigold Transmission Project (“Project”). The Project includes two approximately 4.5-mile 230 kilovolt (“kV”) transmission lines that will connect the Marigold Energy Center solar generation and storage resources to the regional grid via the new Marigold Substation in Pinal County. A map of the Project is attached as **Exhibit A**.

The hearing will be held at the Francisco Grande Hotel and Golf Resort, 12684 W Gila Bend Highway, Casa Grande, AZ, 85193. **The hearing will begin on September 21, 2026, at 10:00 a.m. and will continue as necessary through Friday, September 25, 2026, beginning at 9:00 a.m. each day at the same location until completion of the hearing.** If any additions or revisions to the hearing schedule are required, they will

6 **VIA TELEPHONE, VIDEO CONFERENCING, OR IN PERSON AT THE**
7 **FRANCISCO GRANDE HOTEL AND GOLF RESORT, 12684 W GILA BEND**
8 **HIGHWAY, CASA GRANDE, AZ, 85193. PUBLIC COMMENT MAY ALSO BE**
9 **TAKEN AT OTHER TIMES DURING THE HEARING AT THE DISCRETION**
10 **OF THE CHAIRMAN OF THE COMMITTEE.**

11 **THE PUBLIC CAN WATCH THE HEARING ONLINE, LISTEN TO THE**
12 **HEARING VIA TELEPHONE, OR ATTEND IN PERSON.** At least 24 hours in
13 advance of the hearing, information regarding online and telephone hearing access, as
14 well as any additional details regarding safety protocols or other revisions to the hearing
15 schedule will be noticed on the Project website: <https://www.srp.net/Marigold>.

16 The Chairman may, at his discretion, recess the hearing to a time and place to be
17 announced during the hearing, or to be determined after the recess. The date, time, and
18 place at which the hearing will be resumed will be posted on the above-noted Project
19 website and the ACC website. **NOTE: NOTICE OF ANY SUCH RESUMED**
20 **HEARING WILL BE GIVEN; HOWEVER, PUBLISHED NOTICE OF SUCH A**
21 **RESUMED HEARING IS NOT REQUIRED.**

22 If the Committee decides to conduct a tour, notice that includes a map and
23 itinerary of any such tour will be available at the hearing and posted on the Project
24 website at: <https://www.srp.net/Marigold>. Members of the public may follow the
25 Committee on the tour. During the tour, the Committee may hear testimony at stops on
26

1 the tour concerning elements of the Project. No other discussion or deliberation
2 concerning the Application will occur during the tour. A court reporter or recording
3 device will record any testimony taken on the tour for transcription. Public health and
4 safety protocols specific to the tour will be included on the itinerary. If the Committee
5 decides not to take a tour, the hearing will continue as scheduled.

6 Maps of the Project site and information about project facilities and technology are
7 contained in the Application, which is available for inspection at the following

15 The Applicant will make available final copies of the pre-filing conference, pre-
16 hearing conference, and hearing transcripts at each of the above locations and Project
17 website.

18 Each county, municipal government, and state agency interested in the Project that
19 desires to be a party to the proceedings shall, not less than ten (10) days before the date
20 set for the hearing, file a Notice of Intent to Become a Party with the Director of
21 Utilities, ACC, 1200 West Washington Street, Phoenix, Arizona 85007.

22 Any domestic non-profit corporation or association formed in whole or in part to
23 promote conservation or natural beauty, to protect the environment, personal health, or
24 other biological values, to preserve historical sites, to promote consumer interests, to
25 represent commercial and industrial groups, or to promote the orderly development of

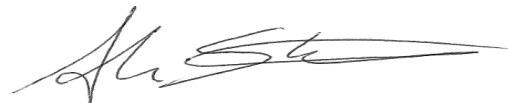
1 the area in which the Project is located desiring to become a party to the proceedings
2 shall, not less than ten (10) days before the date set for the hearing, file a Notice of
3 Intent to Become a Party with the Director of Utilities, ACC, 1200 West Washington
4 Street, Phoenix, Arizona 85007.

5 The Committee may make other persons parties to the proceedings at any time.
6 Any person may make a limited appearance at a hearing by filing a statement in writing
7 with the Director of Utilities, ACC, 1200 West Washington Street, Phoenix, Arizona
8 85007, and the Chairman of the Committee at 2005 North Central Avenue, Phoenix,
9 Arizona 85007, not less than five (5) days before the date set for the hearing. A person
10 making a limited appearance will not be a party or have the right to present testimony
11 or cross-examine witnesses.

12 This proceeding is governed by Arizona Revised Statutes ("A.R.S.") §§ 40-360 to
13 40-360.13 and Arizona Administrative Code R14-7-101 to R14-7-120. No substantive
14 communication not in the public record may be made to any member of the Committee.
15 The written decision of the Committee will be submitted to the ACC pursuant to A.R.S.
16 § 40-360.07. Any person intending to be a party to the proceedings on the matter before
17 the ACC must be a party to the proceedings before the Committee.

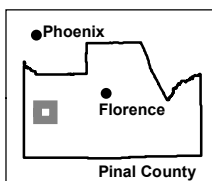
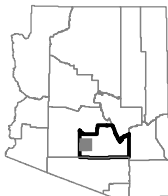
